OBLIGATIONS OF MEMBERSHIP

I/We agree that I/we will make our best reasonable efforts to assure that any vehicle owned by us, or for which I/we are responsible, and is operated in any activity of NJCC; will be driven by a licensed driver in compliance with all applicable provisions of the motor vehicle laws of New Jersey or any other state(s) in which an activity of NJCC takes place; and that the vehicle will be covered by automobile liability insurance meeting or exceeding the statutory requirements of New Jersey or the state in which the vehicle is registered, the insurance being in full force and effect on the date of the activity.

I/We will not participate in any event, meeting or other activity of NJCC while under the influence of alcohol and/or drugs(s) such that would impair my/our ability to perform or participate in the activity and, in particular, to operate a motor vehicle during such activity. I/We acknowledge this obligation on my/our part regardless of whether the particular activity is an NJCC activity or is an activity sponsored by another club or organization and NJCC members are participating as an informal group.

I/We agree to indemnify and hold harmless NJCC and its Officers for any and all claims, loss, damage, injury and/or liability that may be asserted against them by me/us, or by any third party, as a direct result of my/our participation in any activity of NJCC. The foregoing covenants of indemnity are complete, general and without restriction, and include without limitation, negligence (active or passive) or willful, reckless or wanton conduct.
